Participant's Release Form & Indemnity Agreement

I, _____, the undersigned agree:

1. That I will participate in the Texas JAAM Camp and that I have paid the fees that are requested; I agree to participate in these activities and fully understand that I am participating at my own risk.

2. That this camp is sponsored by Texas JAAM Camp LLC in cooperation with Presbyterian Mo-Ranch Assembly, and the location for this camp will be at Mo-Ranch Conference Center, 2229 FM 1340, Hunt, Texas, 78024-3037, and that it will take place from _____ to _____.

3. That the Texas JAAM Camp involves walking between classrooms, place of lodging, and place for mealtime.

4. That I am physically able to do such walking, and that I have no medical problems which may be affected by these activities and any other activity at the camp.

5. That, in lawful consideration for being permitted by Texas JAAM Camp LLC to participate in the activities, I hereby agree that I, my heirs, assigns, guardians, distributees, personal representatives, executors, and relatives will not make a claim against, or file a lawsuit, attach the property of, or prosecute Texas JAAM Camp LLC or Presbyterian Mo-Ranch Assembly and their members, agents, employees, volunteers, partners, assigns, directors and officers, and successors in interest for injury or damage resulting from the negligence or other acts, however caused, by any member, employee, agent, volunteer, or contractor of Texas JAAM Camp LLC, or Presbyterian Mo-Ranch Assembly, or as a result of my participation in any and all of the following activities:

- a. Attendance at all musical instruction events;
- b. All walking, swimming or hiking at the camp;
- c. Dancing and all other recreational activities at the camp;
- d. Automobile travel to, or from airport, or any activity;
- e. Any other activity at the conference.

6. I understand that the swimming pool and some of the swimming areas on the Guadalupe River are not monitored by lifeguards.

7. Further, in consideration of the presentation of the activity, I agree to release, forever discharge Texas JAAM Camp LLC and Presbyterian Mo-Ranch Assembly from any and all such liability, responsibility and obligation to me arising out of the Texas JAAM Camp, and I waive all of my rights, whether they are known to me or unknown to me, as follows: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor." This statement is hereby waived by me: "This release extends to all claims, causes of action, liabilities and obligations of any kind whatsoever which arise out of my involvement with the Texas JAAM Camp, whether they are known to me or not known to me, and whether such claims may exist now or in the future."

8. I agree that I will be covered by my own individual insurance carrier for any personal injury sustained during the course of participating in the activities at Texas JAAM Camp.

9. I agree that execution and timely delivery of this Release are preconditions for my being permitted to participate in the Texas JAAM Camp.

I further agree to indemnify Texas JAAM Camp LLC and Presbyterian Mo-Ranch Assembly, its members, agents, employees, volunteers, owners, successor and assigns and hold them harmless, from any and all liability, responsibility and obligation to me, including but not limited to liability for all acts of negligence which may be committed in Texas JAAM Camp activities listed in 5a through 5e above, and its members, agents, employees and volunteers and which may result in injuries to me. This agreement to indemnify and hold harmless extends to my heirs, assigns, guardians, personal representatives, executors, and relatives. This indemnity agreement extends to all costs of litigation, including attorney fees.
